DIRECTORS' REPORT FOR THE YEAR ENDED 31 DECEMBER 2023

The Financial Statements presented for your examination and approval were audited by Deloitte & Touche S.p.A. and closed with a profit of € 2,100 thousand. The Company has taken advantage of the options provided by the Italian "Anti-Crisis" Decree, implemented by IVASS Provision no. 138 of 25 September 2023, which amends and supplements IVASS Regulation no. 52 of 30 August 2022, allowing it to avoid writing down financial instruments in the portfolio for shorter-term use. The effects of application of the Decree are indicated in Section 14 of these notes.

A description of market trends, the company's situation and its overall business performance is provided below.

1. THE DOMESTIC ECONOMIC SITUATION

For a better understanding of the results, below we provide a brief summary of death insurance trends in Italy, followed by an analysis of the corporate data.

Evolution of the Italian life insurance market

In 2023, the Italian life insurance market, in light of the current climate of strong uncertainty caused by geopolitical instability and inflationary dynamics (against which significantly restrictive monetary policies were implemented) continued to have, indirectly, negative effects on the Italian insurance sector, mainly for the Life business. These macroeconomic elements impacted the savings capacity of customers who, in the face of the new economic scenario, were quickly attracted by more profitable savings instruments, such as government bonds, whose rates of return rose exceptionally during the period between September 2022 and June 2023 (approximately + 400 bps) giving rise to a sudden rise in surrenders from policies.

During the year, the Company collected premiums for a total of € 1,143,936 thousand. Collections were broken down into three sales channels: Credito Emiliano S.p.A., Credem - Euromobiliare Private Banking S.p.A. and Avvera S.p.A.

Credito Emiliano collected premiums totalling € 749,157 thousand, or 65.5% of the total, Credem - Euromobiliare Private Banking collected € 390,813 thousand in premiums, or 34.2% of the total; lastly, Avvera collected € 3,967 thousand in premiums, or 0.3% of the total.

As regards the breakdown of collections, the sales activities of Credito Emiliano were mainly focused on traditional life, revaluable and protection products, which recorded collections for 85.2% of the total, in response to customer demands for investment protection and minimum guaranteed returns; the Segment III insurance-based financial products recorded collections for 9.4% of the total, mainly on Collection and Multi-segment products. A further 5.4% of total premiums collected were recorded on the Retirement fund. The majority of premiums collected by Credem - Euromobiliare Private Banking (57.7%) was for segment III products, with traditional life products accounting for 39.5% and the Retirement fund accounting for 2.8%. Avvera collected all premiums on protection products.

The Company's commercial results show total collections of € 1,143,936 thousand, an increase of 12% compared to the previous year.

The trend in premiums issued during the year was characterised by a portfolio mix with a distribution in favour of Traditional Life products with an increase of 47% compared to the previous year (from € 522,247 thousand the previous year to € 770,332 thousand this year); segment III Unit-Linked products instead recorded a decrease of -28%, from € 409,862 thousand the previous year to € 296,135 thousand this year. Premiums relating to life insurances were down by -22% from € 33,519 thousand to € 26,269 thousand; lastly, Retirement fund premiums (segment VI) fell from € 55,250 thousand the previous year to € 51,200 thousand this year, a drop of 7%.

The pre-tax result is in line with that of the previous year. During the year, the "Anti-Crisis" Decree was applied on the basis of the IVASS Regulation of 30 August 2022, which allows Insurance Companies - under certain conditions, up to certain quantitative limits and in compliance with Supervisory Authority instructions - to avoid writing down securities held in the Company's shorter-term portfolio.

The operating ratios were guided by a financial year characterised by a decline in revenues attributable to capital losses on the portfolio valuations. Company operating costs are up year on year.

Compared to the previous year, the ratio of administrative expenses to premiums was up, due to higher expenses not offset by higher premiums. The ratio with respect to net reserves remained stable, although slightly up due to greater expenditure, with reserves up but with a less dynamic trend compared with the increase in costs.

IVASS Regulation no. 52 of 30 August 2022 defined the "Anti-Crisis" Decree which, under certain conditions, up to certain quantitative limits and in compliance with Supervisory Authority instructions, allows Insurance Companies to avoid writing down securities not expected to remain long term in the Company's portfolio. The choice of securities for which capital losses are not to be suspended is dictated by expectations in terms of the choice of financial instruments to be sold, if this is necessary to meet outflow needs. Therefore, with the aim of preserving the stability of portfolio returns, the securities chosen are expected to be those whose sale would have a more limited impact on separate management rates. These financial instruments were identified as bonds maturing by 2036, less sensitive to any negative impact of changes in market returns, and UCITS/ETFs with capital losses of less than 20%, therefore more able to return to the purchase value if market prices recover.

Solvency Capital Requirement

The solvency position on the basis of the Solvency II legislation framework is determined as the ratio between admissible own funds and the solvency capital requirement (SCR).

On the basis of the matters required by article 62 of Provision no. 53 dated 6 December 2016, the following disclosure in this connection is provided:

- Admissible own funds € 687 million
- Solvency Capital Requirement € 300 million
- Minimum Capital Requirement € 135 million

The solvency ratio is equal to 228.69% as the ratio between own funds and Solvency Capital Requirement, and equal to 451.87% as the ratio between own funds and Minimum Capital Requirement.

The figures indicated represent preliminary data, which could be subject to further up-dates in the drafting of the Report on Solvency and the Financial Condition,

which will be published by 8 April 2024 in accordance with article 47-septies, paragraph 1 of the Private Insurance Code.

This year, business was concentrated on segments I and V, which guarantee a minimum rate of return and recorded collections accounting for 67% of the total, up by 47% compared to the same period of the previous year.

Segment III products accounted for 26% of total collections, down by 28% compared to the same period of the previous year.

Pure risk hedging products connected to personal loans and mortgages account for 2% of the total and collections reported a decrease of 22%.

Segment VI collections fell compared to the previous year by 7%, and represent 5% of total business.

Outflows during the year, gross of reinsurance, amounted to € 1,182,196 thousand (€ 774,451 thousand the previous year).

6. THE MOST SIGNIFICANT FORMS OF REINSURANCE ADOPTED IN THE MAIN SEGMENTS IN WHICH THE COMPANY OPERATES

The company has two "risk premium" reinsurance treaties in place with the company Munich Re, active for individual and cpi "pure risk" life policies and a reinsurance treaty with commercial premiums in place with the RGA International Reinsurance Company LTD for death insurances linked to salary-backed loans. The technical balance of reinsurance is € 558 thousand, compared to a negative € 92 thousand for the previous year.

7. RESEARCH AND DEVELOPMENT AND NEW PRODUCTS INTRODUCED INTO THE MARKET

The Company concentrated its activities on finalising the development activities of IBIPs products that could respond to market developments such as the multi-segment product "Multiramo Platinum by Credemvita" and the segment I product "Risparmio Protetto by Credemvita", placement of which was launched in October and December, respectively.

For its development activities, the Company analyses the strategic positioning of the product mix with respect to the main bancassurance competitors, with a view to seizing the strengths and areas for improvement of the product catalogue, liaises with the sales networks and performs benchmarking analysis of product characteristics

8. FUNDAMENTAL ASPECTS OF THE INVESTMENT POLICY

Own funds and reserves linked to revaluable policies are invested in listed government bonds (71.86% compared to 74.18% in 2022), most of which are fixed-rate (70.88% compared to 73.3% in 2022), listed bonds (13.93% compared to 8.99% in 2022) and mutual investment funds and SICAVs (14.2% compared to 16.80% in 2022). During the period the part of the portfolio invested in listed government bonds decreased, while the components invested in listed bonds, mutual investment funds and SICAVs increased. The situation compared to the previous year is shown below.

8.1 FINANCIAL RISK MANAGEMENT OBJECTIVES AND POLICIES AND THE HEDGING POLICY FOR THE MAIN CATEGORIES OF HEDGED TRANSACTIONS AND THE COMPANY'S EXPOSURE TO MARKET, CREDIT AND LIQUIDITY RISK

This section contains qualitative and quantitative information, developed at market value, regarding the financial risks of the Class C portfolio.

The financial risk management policy is based on a prudential approach aimed at limiting market, credit and liquidity risks. In this spirit, 71.86% of the portfolio is invested in traded government bonds, 13.93% in traded corporate bonds and 14.2% in bond and equity UCITS and those which invest on private markets.

Credit risk is defined as the risk that one of the parties to a financial contract does not fulfil their obligations, damaging the capital of the counterparty. The table below shows the distribution of bonds in the portfolio at the valuation date, by class of ratings assigned by leading ratings agencies:

Liquidity risk is defined as the risk that the Company may not be able to meet its commitments. At the valuation date, the securities in the portfolio had a high degree of liquidity, in that a significant part of the portfolio is invested in government bonds.

Market risk is defined as the risk of loss due to a change in the fair value of a financial instrument caused by changes in interest rates, exchange rates or market prices.

The part of the portfolio, which is invested in bonds, is exposed to interest rate risk proportional to the duration of said financial instruments.

The portfolio is exposed to limited exchange rate risk.

There are no significant positions in dispute other than those linked to the normal and organic management of the insurance operations.

The share capital of Credemvita S.p.A. amounts to € 221,600,070. It is broken down into 42,945,750 shares with a nominal value of € 5.16 each. The share capital is held in its entirety by Credito Emiliano S.p.A.

The company does not hold, and did not purchase or sell, own shares either directly or through third parties or trust companies. The company also has not purchased or sold shares of the parent company. The company does not control other companies and it has no equity investments in parent companies or associates. The Company is subject to management and coordination pursuant to articles 2497 et seq. of the Italian Civil Code by Credito Emiliano S.p.A.

retrocession of management commission on UCITS; securities deposit and asset management agreements; planning and capital management activities; real estate leasing; personnel administration and management services (payroll and salary); contracts relating to EDP services, obligations relating health and safety (Legislative Decree no. 81/2008); services inherent to the Compliance activities; services relating to some tax matters; services relating to Risk Management and services for activities inherent to anti-money laundering legislation; sundry collaboration services in the performance of secretarial activities and corporate fulfilments; digital conservation of archiving of documents and accounting and technical registers (Credemtel Spa); appointments for management of part of the financial portfolio of the Company (Euromobiliare Sgr).

Furthermore, the company availed itself of staff seconded from Credem, from companies in the same Group and from Credemassicurazioni S.p.A., a company 50% owned by Credem.

Credemvita, in turn during the year seconded some employees to Credem and to Credemassicurazioni S.p.A.

12. INTERNAL CONTROL AND RISK MANAGEMENT

Internal control

During the year, internal control activities were carried out by the Credemvita Internal Audit Function.

The Internal Audit Function is responsible for assessing and monitoring the effectiveness, efficiency and adequacy of the Internal Control System and of the additional components of the Corporate Governance System and its updating needs through independent and objective monitoring, assurance and consulting activities, aimed at improving the effectiveness and efficiency of the organisation. It assists the same organisation in pursuing its objectives through a systematic professional approach, which generates added value as it is aimed at assessing and improving control, risk management and Corporate Governance processes.

In line with industry best practices, the audit method is based on a "risk based - process oriented" approach, which involves mapping the Company processes and identifying/assessing the relative risks, as well as identifying the control activities to be carried out on each of the risks identified.

The audit method is based on the following 4 models:

- the process model;
- the risk model;
- the risk and controls assessment model;
- the internal control system representation model.

On the basis of the foregoing, the Company processes were mapped and the relative risks were identified and assessed, making it possible to identify the areas to be audited by internal audit.

The process of mapping, preparing and updating checklists to support audit activities is dynamic and continuously enacted during planned audit activities.

Risk Management

Credemvita S.p.A. adopted a strategy for undertaking and managing risk based on criteria of sound and prudent management, coherent with the company's level of capital. This strategy is based on risk assessment principles that consider aspects relating to their materiality/significance.

The approach followed in risk management is based on the criterion of proportionality and is outlined in specific internal policies pursuant to IVASS Regulation no. 38/2018, for each area of risk affecting the Company.

The key elements through which the Company's risk management strategy and methods are defined are as follows:

- risk identification and classification - risk map;
- risk assessment;
- risk measurement tools and methods;
- risk management;
- monitoring and reporting.

The general principles adopted in defining the risk management system therefore consider:

- verification of the consistency between the level of risk assumed and the expected level of available capital (Risk Appetite);
- the measurability/assessment of risks (when quantifiable) to allow management to assess their impact on the company's performance;
- the determination of processes and operating controls for those that cannot be quantified;
- the presence of a continuous monitoring system for the current and future risk profiles and the related risk and/or return indicators identified.

As part of its risk management system, Credemvita structured and implemented an independent process for assessing its current and future capital adequacy in relation to the significant risks to which the Company is exposed (ORSA - Own Risk and Solvency Assessment process). This process has the following phases:

- Forward-looking assessment of the Solvency II Ratio;
- Stress and Test Scenario (including scenarios for climate risk assessment);
- Forward-looking Liquidity Plan;
- Adequacy of the Standard Formula with respect to the risk profile of the Company;
- Back Testing;
- Self-assessment of the ORSA Process;
- Preparation and submission of ORSA Report.

The following processes are also an integral part of the ORSA process:

- Definition of the preliminary plan and the company budget;
- Definition of the Risk Appetite;
- Risk identification and assessment and Continuous Monitoring.

As part of the Company's strategic guidance, the Board of Directors identifies and approves the correct size of the total capital endowment and the profitability objectives adjusted for the risk. The formulation of preliminary strategic guidelines by the Board of Directors guides the calibration of the risk objectives and the development of the *Strategic Plan*. These activities are significantly connected and are both developed considering the initial situation of the Company, the outlook of the external context, the risk profiles and the orientations in terms of risk/return. The strategic guidelines approved by the Board of Directors are reflected in the production and organisational structure in order to determine the desired impact - in the planning horizon - on the risk/return ratio.

On a continuous basis, the Risk Management Unit supports the corporate bodies in the choices deriving from the implementation of the plan, facilitating the understanding and awareness of the risks assumed/assumable and the monitoring of the same.

The Company also has a set of documents comprising a high-level risk management policy subsequently divided into specific policies, with methodological/technical annexes defined for each risk category or area. Each document provides a detailed description of the objectives, tasks, responsibilities and process, and defines the

tools and procedures (also reporting-related) required to identify, assess and subsequently manage each risk area. Compliance with and application of the documents are guaranteed by the presence of the Internal Control System, comprising a set of rules, procedures, control measures and organisational structures to ensure correct operations and good business performance.

During the year, work was undertaken to continue with the constant consolidation of the current risk management framework, to identify specific risk management processes aimed at mitigating the most significant risk factors and to fine-tune the methods adopted to identify, assess and control the risks.

In light of European regulations on the preparation of financial statement items, which take a "fair value" approach and are supported by international accounting standards (IAS/IFRS), the Company has decided to adopt "market consistent" fair value measurement models for internal Risk Management assessments. Stochastic and/or deterministic valuation models are based on the joint valuation of assets and liabilities.

Furthermore, owing to the European solvency legislation (Solvency II), the Company continued to consolidate the processes aimed at supporting the current and future evaluations of risks in line with the requirements of Pillar I and Pillar II of Solvency II, as well as the data quality and reporting system required by Pillar III.

The main activities performed by the Risk Management Unit in 2023 included:

- Quantification of the Annual SCR and Quarterly SCR;
- Data Quality on the SCR calculation process;
- RSR Report;
- SFCR Report;
- ORSA Report YE 31.12.2023 / 2024-2026 (Regular ORSA);
- Annual report on the adequacy and effectiveness of the risk management system 2023;
- Annual plan of activities 2024;
- Sensitivity, Stress test e scenario analysis both on the solvency capital ratio and in the context of ALM and Liquidity;
- Impact analysis on the Solvency Ratio of the Volatility Adjustment;
- Joint Stress Test with the Parent Company for the Financial Conglomerate.
- Current and Prospective Risk Evaluation – ORSA
- Continuous monitoring of SCR (quarterly) and of risk indicators both at Level I (RAF indicators) and Level II (management indicators relating to the management of risks);
- Identification of risk measures based on Solvency II logics;
- Analysis and control of the risks associated with the investments;
- Analysis and control of risks connected with Asset Liability Management;
- Analysis and control of Liquidity Risk;
- Analysis and control of the underwriting and reserving risk;
- Analysis and controls related to reinsurance risk;
- Operational risk analysis and controls - Risk Self Assessment (RSA) and Loss Data Collection (LDC);
- Analysis and controls on conduct risk factors (for the aspects relevant to the Company);
- ESG risk analysis and controls (with focus on climate risks);
- Qualitative and quantitative profiling of the risks;
- Analysis of the deviation of the Company's Risk Profile with respect to the Standard Formula requirements;
- Annual report on derivatives and complex assets;
- Annual report on risk tolerance of internal funds;
- Control of the limits on the Intercompany Transactions;
- Annual updating of the risk management policies, annexes and related methodological notes (including those relating to the Open-end Retirement fund).
- Annual updating of the Risk Appetite Framework and of the related methodological notes;

- Impact analysis related to significant and extraordinary transactions;
- Risk analysis and target market on new products;
- Assessment of the models adopted in relation to Value for Money;
- Assessment of risk and performance models in relation to KIDs;
- Adaptation to IORP II with preparation of the *Own Risk Assessment of the Open-end Retirement fund*.

13. FURTHER INFORMATION

In continuity with previous years characterised by the COVID-19 emergency, the Company maintained initiatives to ensure business continuity and provide support to its staff and customers, as well as to increase and strengthen management and business governance controls.

In relation to the first of these aspects, with regard to business continuity and staff safety, the Company continued to envisage "smart working" mechanisms for employees (already enabled before 2020). All employees were already equipped with suitable tools for remote work management (laptops, mobile phones and VPN authorisation, use of Google Suite as a work tool and remote collaboration) and were enabled to work remotely, and most of them were already used to operating in this way. For those who had never worked remotely, connections were checked in a timely manner and the appropriate qualifications were expanded.

This allowed:

- the adequate supervision of the processes in progress and of regulatory obligations;
- to continue along the path of Product Oversight Governance, also taking into account the needs of customers linked to the changed scenario.

The company also strengthened the controls on the dynamics of the main commercial, economic, equity and solvency figures, increasing the frequency of the observations and the extent of the analyses of the relevant quantities as well as increasing the forecast simulations through the use of more accurate sensitivities and the determination of a rolling forecast with which, on the basis of the actual results recorded, a projection was determined on a quarterly basis of all commercial, economic and financial data, highlighting any delays.

Overall, considering the year as a whole, management was in continuity with the previous year.

Personnel

At the end of the period, the exact headcount was 71 employees (the average number of personnel hired during the period was also 71).

During the year, a number of employees were seconded on a full or part time basis to Credemassicurazioni S.p.A. (twelve employees), Credito Emiliano S.p.A. (three employees) and Euromobiliare Sgr S.p.A. (one employee).

In 2023, ten employees were seconded to the Company, full-time or part-time, from Credemassicurazioni S.p.A., ten from Credito Emiliano S.p.A. and one from Euromobiliare Advisory Sim S.p.A.

Training activities continued also in 2023 in order to enhance internal skills.

Information Systems

During 2023, the main developments of the information systems of company governance regarded,

with reference to the strategic governance of IT and security:

- the presentation to the Board of Directors in March of the IT Risk Analysis Methodology and the start of the revision to produce the next edition;
- the conclusion of the 2023 report on the forward-looking IT Risk Analysis and relative presentation to the CCR and the March Board of Directors meeting;
- the launch of the new report on the forward-looking IT Risk Analysis 2024;
- the monitoring of key outsourcer service levels;
- the conclusion of 2023 vulnerability tests on outsourcers other than Cedacri on the initiative of the Company and on Cedacri with the support of Credem;
- the removal of IT architecture obsolescence in line with the Company's 2023 plan;
- the adoption of the Information Technology Group Policy and updating of the Company's Regulations;
- the adoption of the Data & Analytics Governance Group Policy and the updating of the Company's Regulations;
- the adoption of the Information Security Group Regulation;
- the adoption of the Group Regulation on Business Continuity;
- the launch of the review of the ICT Change Management Procedure;
- the closure of an audit on the treasury system;
- the initiation of a telephony audit;
- the launch of an audit on IT governance;
- the completion of periodic PSW change activities of all technical users used by the systems;
- the constant monitoring of IT incidents (in particular those suffered in April by the supplier ROTOMAIL).

With reference to the projects:

- the feasibility analysis for the development of a Product Oversight and Governance Dashboard to strengthen and streamline the methods for monitoring the products being placed as required by the company Data Governance model;
- the assessment of systems and processes to make the Company's assistance to the networks and end customers more efficient;
- the start of the Gap Analysis phase to identify the adjustments required by the European DORA (Digital Operational Resilience Act) regulations;
- start of the adjustment of payment systems to the new communication standards envisaged by the interbank circuit;
- preliminary activities for the activation of an advanced contact centre system for the management of communications with customers and distribution networks via e-mail;
- launch of a first phase for the adoption of a process for the management of the purchasing cycle.

With reference to systems release and process optimisation developments:

- the development of new structured and automated Data Quality controls to support processes, in particular for the production of financial statements;
- the development of automatic systems for sending IFRS financial statement data to the Group's Consolidated Financial Statements;
- the further updating of the Business Glossary by the Data Owners and the start of the mapping of the Data Dictionary by the Data Managers for the design of the Company Information Assets;
- activation of the Group's Data Platform (EDP) for a more advanced and shared management of the data present in the Company's Data Management systems;
- the development of other Business Intelligence dashboards to support the needs of company areas;
- the upgrade of the Data Management Platform (IRION) to update the version and increase security;
- the launch of analysis for the creation of a commercial report shared with the Parent Company's PMs through the EDP;

- the completion of activities for the adaptation of Solvency II reporting to the new regulations (EIOPA 2020 Review);
- the revision of the Purchasing Process;
- the analysis and scouting of new suppliers for the evolution of the Treasury Management Process;
- the enhancement of the system relating to the actuarial calculation engine;
- the activation of a module (DSS) in the Finance Platform to allow a more structured and efficient governance of data for reporting purposes, integration with other systems/information providers, etc.;
- the activation of an Application Maintenance service for the management of the accounting platform and the launch of a study to extend it to other company systems.

With reference to personal equipment:

- the disposal of local printers located in the offices. The streamlining of multifunction printers is still in progress;
- the supply of noise-excluding headsets to facilitate video calls in common areas.

More specifically, with regard to developments of the Information Systems serving the Business, the following are of note:

- analysis and implementation of a procedure to adequately manage any customer requests regarding exemption pursuant to Law 197/22 ("2023 Budget Law");
- creation and release for placement of three products with specific funding;
- analysis and implementation of interventions aimed at commercial actions in favour of customers on segment I Capital Light products;
- the release of further interventions to optimise the procedures for the anonymisation of the personal data of the natural persons eligible under the GDPR;
- implementation of an intervention aimed at allowing customers to dematerialise and digitise the DUR (Single Reporting Document) and the consequent possibility of viewing it in the Reserved Area;
- implementation of interventions aimed at the transformation of the placement agent from Banca Euro into Credem Euromobiliare Private Banking and the consequent transfer of customers from Credem to the new entity;
- activities relating to the development of new products continued, some of which are highly innovative, with strong integrations with the placement agent.

Organisation

Governance Model

Credemvita adapted to the provisions of Regulation no. 38, published by IVASS in July 2018, containing provisions on corporate governance systems of insurance companies, accompanied by the Letter to the Market issued at the same time entitled "IVASS guidelines on the application of the principle of proportionality in the corporate governance system of insurance and reinsurance companies and groups". Under the terms of this amendment:

- the Chairperson has a non-executive role;
- in the light of the failed obligation to constitute the Remuneration Board Committee in line with the ordinary regime, assignment to a Director, with the necessary competences, of a specific mandate in relation to the Company's Remuneration and Incentives Policies in order to assist the Board;
- the Fundamental Functions comprise autonomous organisational units reporting directly to the Company's Administrative Body (a similar solution was adopted for the Anti-Money Laundering Function);
- the Articles of Association envisage:
 - the non-executive nature of the role of Chairperson;
 - as regards the composition of the Board of Directors, a maximum number of members (8) and an adequate number of independent members (at least 2);

- also in accordance with the guidelines issued by the Parent Company CREDEM, the concept of "independence" of directors, coinciding with the criteria defined by paragraph 3 of article 148 of Italian Legislative Decree of 24 February 1998 ("Consolidated Law on Finance", or TUF) for the Statutory Auditors of listed companies;
- the establishment of a Board Committee for internal control and risks, with an indication of the relative composition and responsibilities; In particular, the Committee is assigned advisory functions and the powers to make proposals to the Board with regard to:
 - the internal control and risk management system, in order to ensure its adequacy and functionality with respect to the characteristics of the Company, in relation to the evolution of the organisation and operations and the inherent risks, as well as the reference regulatory context;
 - the identification and management of the main business risks.

What indicated above applies, having the Board of Directors of the Company - on the basis of the valuations carried out through the process recommended by IVASS and taking into account the company's risk profile, determined on the basis of the nature, extent and complexity of the risks inherent to the activities carried out - considered appropriate to adopt an "Ordinary" corporate governance for the sound and prudent company management among the three alternatives indicated by IVASS. This valuation was reconfirmed in 2023.

The Company's corporate governance system was integrated with the specific characteristics of the Credemprevidenza Open-end Retirement fund in the light of provisions of the COVIP Resolution of 13 January 2021.

Organisational Structure

In 2023, the Organisational Structure was changed with regard to the operating structures reporting to the General Management, while the structure of the Functions reporting directly to the Board and, in particular, the Key Functions and the Anti-Money Laundering Function, remained unchanged.

The Company's Organisational Structure is structured as described below.

Corporate Centre functions

The following structures report directly to the General Management, whose main responsibilities are reported:

"Governance of Value" Team

It supports the GM in defining and governing the best strategies for creating company value in terms of profit, solvency (regulatory capital) and value for the customer of the policies offered. It monitors the defined value dynamics using the most appropriate calculation methods and metrics, ensuring adequate and sustainable evolution over time under both normal and stress conditions, taking into account current regulations and company guidelines.

The "Governance of Value" Team is responsible for the following activities:

- Budget and Administration,
- Reservation and Reinsurance;
- Pricing and Value For Money;
- Planning and Capital Management, which includes Asset & Liability Management.

"Governance and Innovation" Team

It ensures adequacy and consistency of the organisational model, of the governance information systems and of the operative mechanisms with strategic guidelines, business needs and regulatory provisions, also guaranteeing effective management

of claims and controls on the distribution networks. It oversees the Company's staff training and internal and external communication processes.

The "Governance and Innovation" Team is responsible for the following activities:

- Corporate governance;
- Data Architectures and Information Systems;
- Projects and Processes;
- Communication;
- Controls on distribution;
- Complaints.

"Finance" Team

It ensures the correct application of the strategic investment guidelines defined by the Board of Directors, through sound and prudent management of the securities portfolio, the optimisation of revenues and of the risk of financial positions, the correct and timely preparation of the required disclosures and reports. It ensures effective management of treasury and post-trading activities.

The "Finance" Team is responsible for the following activities:

- Markets and portfolio management
- Post-trading and management delegations.

"Product and Operations" Team

It ensures an effective offer development process in relation to the entire product life cycle, through constant analysis of the market and the reference target market, in line with the objectives of the Company and the principles of Product Oversight Governance. It ensures adequate assistance services to Customers and Networks, as part of a broader monitoring of after-sales processes.

The "Product and Operations" Team is responsible for the following activities:

- product development and management
- operations management.

"Claims Settlement" Team, responsible for:

ensuring the correct and efficient management of activities relating to the processes of opening, investigating and settling claims and managing disputes, through the maintenance of service levels and the continuous improvement of quality levels.

The "Claims Settlement" Team is responsible for the following activities:

- Claims Back Office
- Claims Management and Settlement
- Claims Dispute Management.

"Distribution Relations" Team, with the mission of:

ensuring a positive commercial response to the insurance solutions proposed and contributing to their development, including through specific activities such as events and commercial initiatives; handling the correct training of distributors; guaranteeing timely and proactive management of distribution agreements.

The "Distribution Relations" Team is responsible for the following activities:

- Monitoring of commercial objectives;
- Relations with the distribution and support networks;
- Network training support activities;
- Management of Distribution Agreements;
- Planning and management of events and commercial initiatives

This is a newly established team dedicated to monitoring commercial objectives and relations with the networks.

In light of the new organisational structure as described above, the CRVBSN Organisational Unit - Business Area and the CRVMKS Organisational Unit - Strategic Marketing and Controls Area were closed, with the simultaneous removal of the Strategic Marketing and Control Coordinator Role.

14. BUSINESS OUTLOOK

Following on from actions already taken the previous year, the Company continues to monitor developments in the operational situation, keeping its main operating, economic, equity and solvency figures under observation, especially with reference to the trend of surrenders which increased markedly during the year.

In order to monitor contextual changes, the Company introduced specific monitoring and governance of the impacts of inflation on its business model.

With reference to the inflationary context, the Company adopted an analysis framework with the aim of:

- Promptly intercepting changes in the scenario variables in order to have effective governance of the Company's forecast processes and planning objectives;
- Verifying impacts on the business model by analysing the short- and long-term impacts and the possible mitigation tools linked to the new inflation expectations.

The analysis showed, in the short term, that the increase in inflation would have an insignificant impact on the Company's business model.

In this respect, for 2024 the business model development is expected to be fully operational, without substantial changes to the company's business model and its approach to risk assumption, reserving and managing reinsurance positions.

At the same time, all the controls implemented will remain in place and fully active in relation to: actions suitable to guarantee business continuity; customer support initiatives; employee support initiatives; strengthening of management and business governance controls with particular attention to those necessary to continuously verify the achievement of its business plan objectives both in terms of premiums collection and economic and financial results and to continuously monitor the dynamics of its solvency position. It should also be noted that the perpetuation of the situation is not generating changes and/or alterations in the company's business model or in its risk profile.

Lastly, note that, with reference to the geopolitical situation linked to the conflict between Russia and Ukraine and, since October 2023 with the conflict in the Middle East, the Company, in line with its Group, is monitoring the development of events with particular regard to additional risks that the conflicts could generate for global economy and financial market trends. The war events could have wide-ranging consequences on market growth, inflation and volatility, and likewise repercussions on households and businesses.

At present, though the planning scenario does not take into account the potential effects of the Russia/Ukraine and Middle Eastern conflicts, note that observation of the phenomenon to date has not given rise to sufficient elements to require review of the Company's planning, or any certain or systematic circumstances that would affect its risk profile and capacity to achieve its planned objectives.

In this respect, in fact, for 2024 the business model development is expected to be fully operational, without substantial changes to the company's business model and its approach to risk taking, reserving and managing reinsurance positions.

The Company's objectives reflect the strategy of ensuring its sustainable, balanced growth with a view to increasing its technical reserves, increasingly serving customer requirements through a holistic advisory approach, which, analysing their multiple saving, investment and protection needs, seeks solutions for building value over time.

More specifically, by gradually seeking insurance solutions that respond promptly to changing needs on the one hand, and trying to focus policies on the specific

characteristics of certain customer categories on the other, the product range becomes increasingly personalised.

The 2024 operative planning for the Company is focused on a net positive collection target of around € 459 million, up markedly with respect to net production for the year, which came to € -51 million.

In particular, the increase is attributable to the product mix, which in 2024 envisages strong growth in Unit-Linked policies compared to the year, for which net collections of around € 172 million are estimated compared to € -132 million in collections at the end of the year, and a lively trend in revaluable policies, for which net collections of around € 254 million are estimated compared with € 39 million at the end of the year.

For 2024, however, the Company's offering will be inspired by its goal of achieving the utmost satisfaction of customer requirements while protecting and ensuring adequate returns on investments. Segment III policies (including the Multi-segment component) are expected to achieve net collections of around € 172 million, mainly focused on the Unit-Linked family of policies called Credemvita Collection and Multi-segment. Segment I and V revaluable policies are expected to achieve net collections of around € 254 million, mainly focused on the Multi separate management and Multi-segment family of policies. For the year 2024, the commercial activities of the placement agents will focus on the products currently being placed and on the launch of new products linked to a Specific Asset Supply and a new Multi-Segment. The flows of premiums issued from policies linked to the separate management are expected to be around € 694 million, while those from Unit-Linked policies are expected to be around € 554 million. Lastly, net collections indicated previously are augmented by around € 36 million in collections from the retirement fund and temporary life insurances (both individual and collective), in line with the € 35 million recorded during the year).

15. SIGNIFICANT EVENTS SUBSEQUENT TO YEAR END

Also in the light of information provided above, no significant events materialised from the end of the year until the date of presentation of the draft Financial Statements, which are certain to significantly affect the balance sheet and financial situation or the economic result under review.

16. CONCLUSIONS AND PROPOSED ALLOCATION OF PROFIT FOR THE YEAR

The financial statements have been prepared in observance of measurement principles and criteria compliant with the provisions established by the Italian Civil Code, Italian Legislative Decree no. 173 dated 26 May 1997, Italian Legislative Decree no. 209 dated 7 September 2005 and ISVAP Regulation no. 22. The Company's financial statements have been prepared on a going concern basis, taking into consideration its adequate level of capitalisation, which exceeds the minimum solvency requirements established by current regulations, and the forecast future results.

It is proposed that the profit for the year of € 2,099,810 be allocated as follows:

- € 104,990 to the legal reserve;
- € 1,994,820 to the extraordinary reserve.

NOTES TO THE FINANCIAL STATEMENTS AS AT 31 DECEMBER 2023

FORM, CONTENT AND ACCOUNTING STANDARDS OF THE FINANCIAL STATEMENTS

The financial statements, which include the Balance Sheet and Income Statement as well as the Notes and related attachments and are accompanied by the Directors' Report, have been prepared in compliance with the provisions pursuant to Italian Legislative Decree no. 209/2005 and Italian Legislative Decree no. 173/1997. Furthermore, the Balance Sheet and Income Statement formats have been drawn up in accordance with the provisions of Regulation no. 22 of 2008. They were also prepared in line with the circulars and other provisions issued by the Supervisory Authority, special industry regulations and, when applicable and if not conflicting with the regulations referred to previously, the accounting standards of the Italian National Councils of Professional and Certified Public Accountants, the Italian Accounting Standard Authority, instructions provided by the national industry association ANIA.

Since the Company is authorised to operate exclusively in the Life segments, the attachments envisaged under Regulation no. 22 of 2008 relating to the Non-Life segments have not been compiled and commented on. The Statements of the Credemprevidenza - Open-End Retirement Fund (attachment B to these financial statements) have been prepared for each segment (secured bond, balanced, equity and flexible), and include the respective notes and are accompanied by the Directors' Report (attachment A to these financial statements).

No special events took place that would require using the exemptions pursuant to art. 2423, paragraph 4 and art. 2423 bis, paragraph 2. Furthermore, when necessary, the risks and losses for the year are taken into account even if they were known only after year-end.

In compliance with the provisions of Regulation no. 22 of 2008, cited above, these notes include the following parts:

- "A" Measurement criteria
- "B" Notes to the balance sheet and income statement
- "C" Further information.

The values reported in the financial statements are in euro, with no decimals, while the values reported in these Notes, including the relative attachments, are expressed in thousands of euro.

PART A – MEASUREMENT CRITERIA

Section 1 – Disclosure of measurement criteria

The measurement criteria used to prepare the financial statements comply with the principle of prudent accounting and adopt the going concern assumption, taking into account what is reported in the directors' report.

Account was also taken of the principle of prevalence of substance over form, i.e. the economic function of the asset or liability element considered, according to the accruals. In compliance with current regulations, no items have been offset. The accounting standards and measurement criteria adopted meet the objective of providing a clear, true and fair view of the Company's balance sheet, financial position and net result for the period, and are the same as those used for the previous year.

The standards and criteria adopted are described below for each financial statement item.

Start-up and expansion costs and other long-term costs

Intangible assets, considered to be for long-term use, are recognised at purchase cost inclusive of directly attributable accessory charges.

Intangible assets are recognised and amortised, with the consent of the Board of Statutory Auditors, based on their useful life, as established in art. 2426 of the Italian Civil Code. The following rates are used:

- 20% start-up and expansion costs and expenses for improvements to third-party assets;
- 20% for software with a useful life of at least 5 years;
- 33% for other expenses of updating EDP procedures and software usage licences;
- days of effective competence for the bond issue charges;
- 6 years (average duration of contracts) for other acquisition costs to be amortised.

The above-mentioned costs with long-term useful life are directly adjusted through amortisation.

If the net amount, calculated as noted above, exceeds the amount reasonably expected to be recovered in future years, the corresponding impairment is recognised. This amount is written back in subsequent years if the reasons for recognising the impairment are eliminated.

Investments

The breakdown between financial investments for long-term use and financial investments for short-term use complies with the criteria established by the applicable Investments Policy.

IVASS Regulation no. 52 of 30 August 2022 defined the "Anti-Crisis" Decree which, under certain conditions, up to certain quantitative limits and in compliance with Supervisory Authority instructions, allows Insurance Companies to avoid writing down securities not expected to remain long term in the Company's portfolio. The choice of securities for which capital losses are not to be suspended is dictated by expectations in terms of the choice of financial instruments to be sold, if this is necessary to meet outflow needs. Therefore, with the aim of preserving the stability of portfolio returns, the securities chosen are expected to be those whose sale would have a more limited impact on separate management rates. These financial instruments were identified as bonds maturing by 2036, less sensitive to any negative impact of changes in market returns, and UCITS/ETFs with capital losses

of less than 20%, therefore more able to return to the purchase value if market prices recover.

1. Shareholders' equity - suspended capital losses - available reserve - unavailable reserve and dividend income distribution (Italian Decree Law 73/22, art. 45(3-octies) and (3-decies)(1), (2) and (3))

Illustration of the criteria for calculating the effect of commitments to policyholders

For the 2022 financial year, the Company, in relation to the allocation of the unavailable reserve, in order to determine the effect of the existing commitments to the policyholders, as envisaged by art. 1(3) of IVASS Provision no. 127 of 14 February 2023 (amending and supplementing art. 5(1) of IVASS Regulation no. 52) made use of the following assumptions:

- Use of 5-year real world return vectors (and mathematical reserves) as per the ALM Report as at 31/12/2022 presented to the Company's investments Committee on 26/01/2023
- Use of the same technical and financial assumptions as per the official valuation as at 31/12/2022
- Compared to the official assessment, the report shows the following differences:
 - In determining existing commitments to policyholders, the projections were made in a closed portfolio scenario (therefore excluding premiums from new business)
 - In determining the existing commitments to policyholders, the projections were made in a scenario that assumes realisation of the capital loss in 5 years.

For the year 2023, the Company did not make use of the option granted by Provision no. 143/2024 of 12/03/24 amending IVASS Regulation no. 52/2022 for the retrocession of existing commitments to policyholders, in a context of no dividend income distribution.

Class C investments

Investments in fixed-income securities

Financial investments for shorter-term use

Listed fixed-income securities are measured and recognised at the lower of book value or market value at the date of year-end, calculated on the basis of the price on the last market day of the year. The book value is represented by purchase cost, calculated using the method of running weighted average cost by movement. This value is increased by the share of the issue spread for the year.

For implicit rate securities (zero coupon), the amount of capital appreciation for the year is recognised on an accrual basis.

Unlisted bonds are measured at the lower of the above-mentioned weighted average cost and the presumed realisable value at year-end inferred from the main contributors or, if unavailable, calculated with reference to listed securities with similar characteristics or on the basis of other objective elements.

Any write-backs are recognised within the limits of the write-downs recognised previously.

Financial investments in derivative instruments

The value of derivative financial instruments that satisfy the conditions of article 37-ter, paragraph 3, letter a), of the Code is taken into account for the purpose of the evaluation of the assets linked to them. The criteria used to measure derivative financial instruments that represent assets or liabilities of the company are in any case consistent with the solutions adopted to determine the value of the underlying assets.

These notes specifically highlight the differences between book values and market values at year-end.

Financial investments for long-term use

Bonds are measured at purchase cost, calculated using the method of running weighted average cost by movement, in addition to the accrued issue spread and adjusted by the positive or negative trading spread for the year accrued at year-end. These investments are written down at year-end in case of impairment. The write-down may be written back in subsequent years if the reasons for the impairment are eliminated.

For implicit rate securities (zero coupon), the amount of capital appreciation for the year is recognised on an accrual basis.

These notes specifically highlight the differences between book values and market values at year-end.

Investments in mutual investment funds and SICAVs - ETF

Mutual investment funds and SICAVs, recorded in the segment of financial investments for short-term use, are valued at the lower of the book value recognised in the accounts and the year-end value disclosed by the manager. The book value is represented by purchase cost, calculated using the method of running weighted average cost by movement. For these securities, any write-backs are recognised within the limits of the write-downs recognised previously.

Class D investments (investments benefiting life policyholders who bear the risk and from pension fund management)

The value of class D investments covering contracts pursuant to art. 41 of Italian Legislative Decree no. 209/2005 is determined on the basis of the current value expressed on the last transaction day of the year, as officially communicated by the issuing entities on the basis of their valuation and, for listed securities, adopting the values expressed in the reference market.

Securities and units belonging to class "D" investments are considered investments not destined to remain part of the company's assets in the long-term.

Technical reserves attributable to reinsurers

The company has the following reinsurance agreements:

- "excess agreement with annual risk premiums" entered into with Munich Re;
- "excess quota agreement with single risk premiums" entered into with Munich Re;
- "proportional quota agreement with single premiums" entered into with RGA International Reinsurance Company.

Technical reserves attributable to reinsurers are recognised for reinsurance coverage, applying the conditions of the agreements.

Receivables

Receivables are recognised in the financial statements at presumed realisable value.

Other asset items:

Property, plant and equipment and stock

Property, plant and equipment are recognised at purchase cost inclusive of directly attributable charges. The value of these assets, calculated as noted above, is systematically depreciated based on the remaining useful life. Depreciation is

calculated using rates meant to represent deterioration for the year. The rates adopted, which also meet fiscal criteria, are the following:

- 12% furniture and ordinary office machines
- 15% fixtures
- 20% electronic office machines
- 25% vehicles

Ordinary maintenance and repair costs are allocated to the income statement in the year in which they are incurred. Stock, especially printed materials and consumables, is fully expensed during the year for prudent valuation purposes.

Please note that monetary and economic revaluations or exemptions pursuant to articles 2423 and 2423 bis of the Italian Civil Code have not been applied and that the company has no assets previously subject to revaluation pursuant to Italian Law no. 72 of 19 March 1983.

Cash and cash equivalents

Cash and cash equivalents are recognised at their actual nominal amount.

Accruals and deferrals

Accruals and deferrals are calculated and recognised in accordance with the accrual principle.

Guarantees, commitments and other memorandum accounts

These are recognised in the financial statements at the equivalent value of the commitments assumed and guarantees given. The amounts of securities deposited with third parties are calculated at book value.

Technical reserves

Mathematical reserves

These are calculated specifically for each contract using technical actuarial techniques in line with the provisions envisaged by Attachment no. 14 to ISVAP Regulation no. 22 (hereinafter "IVASS Attachment no. 14") and are sufficient to cover commitments undertaken in relation to policyholders.

Mathematical reserves are valued based on pure commitments, in line with the commitments assumed by the Company pursuant to the Special Conditions of the individual rate types and revaluation criteria, for types that are part of separate management.

To calculate the mathematical reserves, the recurrent method is used for rates for benefits subject to revaluation and the prospective method is used for rates for life insurance and outlined in the report of the actuarial unit.

Additional reserves for financial risk

To determine the value of the additional reserve for guaranteed interest rate risk for the individual separate management portfolios and, within these, for each level of financial guarantee given on the contracts, the Company determined the current and expected return for each separate management portfolio in compliance with the provisions pursuant to articles 24 to 31 of the IVASS Attachment no. 14, and by applying the calculation principles and methods pursuant to articles 33 and 34 of the same.

Additional reserve for demographic longevity risk

For immediate life annuity contracts with first-order demographic bases, an additional reserve has been recognised for demographic risk in compliance with the provisions as per articles 36 to 38 of IVASS Attachment no. 14.

Reserves for amounts to be paid

The reserves for amounts to be paid take into account the capital to be paid for all policy payments pending at year-end for surrenders, claims and maturities, in compliance with art. 23-bis(5) of ISVAP Regulation no. 22.

Other technical reserves: reserve for future expenses

The other technical reserves mainly consist of reserves for future expenses, calculated contract by contract on the basis of the management cost loading envisaged for the individual rates. In particular, the methods for calculating the reserve for future expenses are described in section 10 of these Notes.

Additional reserve for demographic mortality risk

For rates for Temporary Life Insurance, an analysis using second-order development assumptions was conducted in order to verify a realistic coverage of the risks assumed by the Company. This analysis was conducted on policies existing at the reporting date, broken down by Individual and Group rates.

Technical reserves included in class "D" under liabilities

For contracts under which the investment risk is borne by policyholders, in compliance with article 41, paragraphs 1 and 2 of Italian Legislative Decree no. 209/05, the mathematical reserves correspond to the market value of the relative assets allocated for coverage purposes in class "D" under assets.

Provisions for risks and charges

Provisions for risks and charges are used to cover losses or payables the nature of which is known and which are certain or likely to exist, but for which the amount or the date on which they will arise are unknown.

Payables

Payables are recognised at nominal value.

Provision for employee severance pay

This represents the liability at year-end to all employees. It is calculated in compliance with article 2120 of the Italian Civil Code, Italian Legislative Decree no. 47 of 18 February 2000 and collective labour agreements in force, taking into account the years of service of each employee and the wages earned.

Premiums and additional charges for the year

Premiums, inclusive of additional charges, are accounted for on an accrual basis regardless of the date on which they are actually collected.

Acquisition commissions

Acquisition commissions are recognised in full during the year.

Income and charges

These are recognised in the Income Statement in accordance with the principle of prudence and the accrual principle.

Current, deferred and prepaid taxes

Current income tax due for the year is calculated in compliance with tax laws in force, on the basis of a realistic and prudent estimate of total taxable income. This charge is recognised in the income statement on an accrual basis, and has a balancing entry under "Payables for other taxes".

Deferred tax assets and liabilities are recognised in the income statement as an adjustment and/or addition to "Income taxes for the year" with a balancing entry, respectively, under "Other receivables" and/or "Tax provisions".

Deferred tax liabilities and assets are calculated based on the tax rates in force in the year in which the repayment occurs. The provisions of accounting standard no. 25 and the principles of prudence established in article 2423 bis of the Italian Civil Code were observed for the allocation of deferred tax assets.

In fact, deferred tax assets are recognised only if there is a reasonable certainty that taxable income of at least the total amount of the correlated positive tax effects will be generated in the years in which such effects are produced.

Deferred tax liabilities are recognised only if prerequisites for translating the latent tax charge into an actual tax charge are met.

Foreign currency translation

Items in foreign currency are translated in compliance with OIC 26.

Transfer of the share of profit from investments

According to attachment 11 of Regulation no. 22 of 2008, a share of profit from investments is transferred from the technical account to the non-technical account.

PART B – NOTES TO THE BALANCE SHEET AND INCOME STATEMENT

The company is authorised to operate in the life segments: therefore, it is not required to prepare separately a balance sheet relating to the non-life and life segments, or to break down the result for the year between the non-life and life segments.

In accordance with article 2427 of the Italian Civil Code, the amounts of the asset, liability and income statement items are described along with the changes that took place during the year and the information required for the individual items.

The values referred to within the individual items and tables are expressed in thousands of euro.

BALANCE SHEET – ASSETS

Section 1 – Intangible assets (item B)

The opening balances correspond to the closing balances at the end of the previous year, net of long-term costs fully amortised at the beginning of the year. The item "Receivables pursuant to Italian Decree Law no. 209/02 relating to technical reserves" includes a € 172,609 thousand tax credit on mathematical reserves, due pursuant to Italian Decree Law of 24/9/2002, converted with amendments by Italian Law no. 265 of 22 November 2002, net of uses during the year. To calculate the increase in receivables pursuant to Italian Decree Law no. 209/02, the amount for the year was estimated by taking into account the theoretical rate of 0.50%, followed by the recalculation, which will take into consideration the caps applied pursuant to art. 1(507) of Italian Law no. 228 of 24/12/2012, as amended, in force at the time of the final tax settlement. The receivable calculated in this manner is recovered by subtracting it on a case by case basis from withholding tax and substitute tax payments calculated at the time of disbursement of capital returns to be paid on the basis of the relative insurance policies. An additional possibility to recover that receivable was introduced beginning in 2007 by Italian Decree Law no. 168/2003, when the total amount of the above-mentioned substitute and withholding taxes to be paid each year is lower than the tax on reserves paid for the fifth previous year. In that case, the difference may be fully or partially offset against taxes and contributions pursuant to article 17 of Italian Legislative Decree no. 241 of 9 July 1997, also beyond the limit established in article 34, paragraph 1 of Italian Law no. 388 of 23 December 2000.

During the year, no IRES and IRAP tax advances were paid.

The IRAP and IRES receivables originated from the significant amounts of advances paid in previous years to which, due to the performance of the financial markets, results for the year were not in line with the payments on account.

The item "Receivables for retrocessions on commission" includes receivables for management commission recognised to the Company by management companies of the UCITS present in the portfolio, on the basis of specific agreements: part of this commission is then retroceded to the policyholders.

The item "Withholdings on SICAV income" includes the equivalent value of advance withholding tax on SICAV-related income.

- The issued bond is a non-convertible instrument, at a fixed rate, issued below par at 98.330%, on 18 November 2020 and called "Credemvita s.p.a." ISIN code XS2253071216 in Euro currency. The security has the following characteristics:
 - Nominal value: € 107,500,000;
 - Maturity date: 18 February 2031;
 - Coupon: Fixed annual rate, set at the time of issue at 3.5% for the first 5 years. The interest rate will be reviewed at the end of the fifth year, without application of any step-up mechanism;
 - Rating: BBB- by Fitch.

The reimbursement of the Bond may take place - besides on its natural maturity date - on expiry of the fifth year, or on occurrence of a "Regulatory Event" (or rather in the event that the securities no longer have the characteristics for admissibility and inclusion in the company's level 2 basic own funds, in compliance with market practices, in the event that the Company should no longer be subject to the supervision of IVASS) and of a "Tax Event" (or rather if, due to the introduction of new tax rules, or the amendment of the existing ones, the Company should be subject to the payment of additional taxes on the Bond or should no longer be in a position to deduct the interest paid on the Bond).

The same may in any event take place, with the exception of the hypothesis in which the reimbursement may cause the insolvency of the Company, in the event that - in

compliance with the matters envisaged by the Delegated Regulation - IVASS has decided on an exceptional basis not to apply the suspension of the reimbursement, the Bond is exchanged or converted with another element of the own funds on the basis of the same quality and the minimum capital requirement is observed after the reimbursement.

These financial instruments were identified as bonds maturing by 2036, less sensitive to any negative impact of changes in market returns, and UCITS/ETFs with capital losses of less than 20%, therefore more able to return to the purchase value if market prices recover.

Mathematical provisions evaluation

Description of the key audit matter On December 31, 2023 the Company recorded in section C.II "Life Insurance business", mathematical provisions for an amount equal to Euro 4,451 million.

As highlighted by the Directors in the explanatory notes in "Part A – Evaluation criteria", the valuation of the life technical provisions requires a high level of subjectivity and the use of complex estimates related to historical experience and assumptions that are considered reasonable and realistic based on the relevant circumstances. The application of such estimates and assumptions affects the values indicated in the financial statements and the information provided.

The Company reports the criteria followed and the methodologies applied to determine mathematical provisions in "Part A - Evaluation Criteria" of the explanatory notes.

In consideration of the significance level of the amount of mathematical provisions recorded in the financial statements and the existence of the discretionary component linked to the estimation nature related to technical, actuarial, demographic, and financial assumptions and hypotheses, as well as, with reference to the estimate of some types of additional reserves, the forecasts of future cash flows arising from insurance contracts concluded and existing at the closing date of the financial, we considered the evaluation of mathematical provisions a key matter for our audit of the Company's financial statements as of December 31, 2023.

Audit procedures performed The audit's procedures carried out, also with the support of specialists within the Deloitte network, included several procedures; the most relevant are outlined below:

- understanding of estimation process of mathematical provisions that included the Director's understanding of operational strategies as well as any changes in the regulatory and industry framework;
- identification and verification of the relevant controls implemented by the Company on the process of evaluating technical reserves;
- Verification procedures regarding the completeness and adequacy of the reference portfolios and their underlying data;
- Reading and analysis of the reports on technical reserves prepared by the relevant corporate functions;
- Verification of the calculation of mathematical reserves using simplified methods (so-called "recurring method") in order to assess the reasonableness of the reserve values determined by the Company's Director;
- Recalculation, for a selection of insurance contracts in the portfolio, of the mathematical reserve value as of December 31, 2023, using the calculation formulas specified in the policy technical notes, and analyzing the compliance of the calculation with company procedures and regulatory requirements;

- reasonableness analysis of the methods and key technical assumptions and developments on which the estimates of additional reserves included in the mathematical reserves were based, in accordance with the relevant regulatory requirements;
- verification of the completeness and adequacy of the information provided by the Company in the explanatory notes to the financial statements compared to what is required by applicable regulations.

Analysis of the effects resulting from the application of IVASS Regulation No. 52 of August 30, 2022

Description of the key audit matters

On December 31, 2023, the Company utilised the optional regime introduced by Decree-Law No. 73 of June 21, 2022, in accordance with the application methods regulated by IVASS through Regulation No. 52 of August 30, 2022, as amended by IVASS Provision No. 143/2024 of March 12, 2024 (below the "Regulation"). The exercise of this option allowed the Company to evaluate a portion of the assets recorded in the non-durable sector at the value reported in the 2022 financial statements, or, for financial instruments not present in the portfolio as of December 31, 2022, at the acquisition cost, avoiding the recording of Euro 121.5 million in value adjustments in the income statements. This had a positive impact on the net result for the year of Euro 92.8 million, considering the tax effect.

As described by the Director in the explanatory notes to the financial statements, for the purpose of identifying the securities to which applies this option, the Company developed a projection of expected cash flows, using prudent assumptions and also taking into account stress scenarios. This analysis also demonstrated the consistency of the valuation of non-durable securities with the structure of existing financial commitments and the maturity of the related payments.

As required by the mentioned above Regulation, the Company has also established an unavailable reserve equal to the amount of the avoided devaluation on the financial instruments to which the option was applied, considering the related tax effect, by allocating equity reserves.

As highlighted by Director in the explanatory notes to the financial statements, the Company did not avail itself of the option provided by IVASS Provision No. 143 of March 12, 2024, which modifies and supplements the Regulation, to also consider in the calculation of the unavailable reserve the effect of existing commitments towards policyholders.

The Company reports in Section 1 – Illustration of the valuation criteria of Part A of the explanatory notes to the financial statements the criteria followed for the identification and valuation of securities for which it exercised the option, the comparison of the recorded value as of the closing date of the balance sheet with the value derived from market trends, as well as the economic effects resulting from the application of the Regulation. Considering the significance of the effects resulting from the application of this exception and the relevance of the discretionary component inherent in the process of identifying the financial instruments to which this option

applies, we thought that the effects arising from the application of IVASS Regulation No. 52 represent a key matter for our audit of the Company's financial statements as of December 31, 2023.

Audit procedures performed

We first gained an understanding of the Company's investment process, which encompassed comprehending Director and strategic directions. Our review procedures in this area entailed identifying and understanding the pertinent controls set by the Company and conducting verification procedures to ensure compliance with corporate directives and investment Director policies.

Regarding the application of IVASS Regulation No. 52 of August 30, 2022, we have conducted the following primary procedures:

- understanding the process under the identification of financial instruments to which the option granted by the Regulation applies;
- acquisition and analysis of the report signed by the heads of the Risk Management function and the Actuarial Function as required by Article 4 of the Regulation;
- verification, on a selection of financial instruments, of their correct valuation in the balance sheet as of December 31, 2023, derived from the carrying value in the 2022 financial statements (last approved annual financial statements) or from the acquisition cost, in the case of newly acquired financial instruments;
- recalculation, for a selection of financial instruments, of the differences resulting from the comparison between the book value as of December 31, 2023, and the market value at that date;
- analysis of the criteria used to determine the unavailable reserve;
- verification of the completeness and adequacy of the disclosure provided by the Company in the explanatory notes to the financial statements, in relation to what is required by the relevant regulations.

Other aspects

The financial statements of Credemvita S.p.A. for the year ended December 31, 2022, were audited by another auditor who, on April 4, 2023, issued an unmodified opinion on these financial statements.

In accordance with Article 2497-bis, paragraph 1, of the Italian Civil Code, Credemvita S.p.A. has indicated that it is subject to the management and coordination of Credito Emiliano S.p.A.. Therefore, it has included essential data from the latest financial statements of Credito Emiliano S.p.A. in the explanatory notes to the financial statements. Our opinion on the financial statements of Credemvita S.p.A. does not extend to these data.

Responsibilities of Directors and Those Charged with Governance for the Financial Statements

The Directors are responsible for the preparation and presentation of the financial statements, that give a true and fair view in accordance with Italian regulations governing financial statements, and, within the terms provided by the law, for such internal control as they determine is necessary to enable the preparation of financial statements that are free from material misstatement, whether due to fraud or error.

In preparing the financial statements, the Directors are responsible for assessing the Company's ability to continue as a going concern, disclosing, as applicable, matters related to going concern and using the going concern basis of accounting unless they either intend to liquidate the Company or to cease operations, or has no realistic alternative but to do so.

The statutory audit committee ("Collegio Sindacale") is responsible, within the terms provided by the law, for overseeing the Company's financial reporting process.

Auditor's Responsibilities for the Audit of the Financial Statements

Our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not a guarantee that an audit conducted in accordance with International Standards on Auditing (ISA Italia) will always detect a material misstatement when it exists. We have communicated with those charged with *governance*, identified at an appropriate level as required by ISA Italia, regarding, among other matters, the planned scope and timing of the audit and significant audit findings, including any significant deficiencies in internal control that we identify during our audit.

We have provided those charged with *governance* with a statement that we have complied with the ethical and independence requirements applicable in Italy, and we have communicated with them all matters that may reasonably be thought to bear on our independence, and where applicable, related safeguards.

From the matters communicated with those charged with *governance*, we have determined those matters that were of most significance in the audit of the financial statements of the current period and are therefore the key audit matters. We have described these matters in our auditor's report.
